He was the ideal Teddy in Arsenic and Old Lace and unforgettable as Vice President Throttle-bottom in Of Thee I Sing.

George was a successful director, too and scarcely a production was offered that did not find George working with the scenery and other phases of backstage work. He served on our Board of Directors and was at one time Vice President of NFCT. But above all, he will be remembered as a friend who made things seem easy and his associates feel better for having known him.

BOB ACKROYD (Dr. Homer Raschid) - Not Dan Ackroyd's brother!!! However, his brother Dave is a professional actor who has appeared frequently on T. V., Broadway and now in movies.
